## Course Objectives

This required course is to addresses selected civil engineering body of knowledge topics including preparation for the NCEES Fundamentals of Engineering (FE) Exam, the importance of licensure, leadership and management, public policy, business aspects of engineering, and others. It integrates technical, professional, and social issues and contributes to the preparation of senior BSCE students to enter professional practice.

During this course the student will

1. Explain the purpose, scope, and current nature of the NCEES FE Exam as it relates to licensure

- 2. Apply resources and strategies to prepare for the FE Exam
- 3. Work FE Exam-like questions in selected morning and afternoon session topics using the FE Supplied Reference Handbook
- 4. Explain key concepts and processes associated with selected civil and environmental engineering body of knowledge topics such as leadership, business and public administration, and public policy
